Minutes of Argoed Community Council meeting held on 15th June 2015 at Manmoel Village Hall.

- 1466 To sign the register and receive apologies
- 1466.1 Community Councillors present: Chairman W. Williams, G. Bineham, D. Briggs, A. Jones, G. Lewis, K. Masson, H. Rowlands, J. Watkins and M. Williams.
- 1466.2 Apologies were received from Councillor L. Gardiner and A. Craddock
- 1467 To receive a report from the Police.
- 1467.1 Jeff Dugmore reported that a joint venture between Caerphilly and Blaenau Gwent Police had taken place to combat the problems of off-road bikers and 4X4s.
- 1467.2 Speed checks on Abernant Road and Hollybush main road have been carried out and Penylan Road is yet to be done. Community Speed watch is being introduced in the Argoed area.
- 1467.3 Yellow lines are planned for outside Markham Primary School to try and reduced the problems of parking. Obstruction of the bus stop is still a problem.
- 1467.4 The meeting discussed the possibilities of the introduction of 20 m.p.h. speed limits in the vicinity of the school
- 1468 To receive a report from Cllr Leon Gardiner. Leon had previously given his apologies.
- 1469 The minutes of the previous meeting held on 18th May 2015 were agreed.
- 1470 Matters arising:-
- 1470.1 Minute 1457 it was noted that the Football and Netball tournament had been a great success.
- 1470.2 Minute 1460.4 letter to Caerphilly County Borough Council requesting a sign be placed at the entrance to the former Markham Colliery Site.
- 1470.3 Minute 1461 Cllr David Briggs reported that a site visit had been carried out at Markham Miners' Institute and the provision of an external power source can now be completed. The Institute has agreed to pay for the cost of the electrical work.
- 1470.4 Minute 1464.1 letter to be sent to Natural Resources Wales expressing concern about the suspected pollution of the river Sirhowy. Letter to be sent to Caerphilly County Borough Council regarding the activities at Dyers Dip. Also

- write to the Cabinet Member for Environmental Issues expressing the Community Council's concerns about the dumping of burnt-out cars in the river.
- 1471 The schedule of correspondence provided by the Clerk was received and the required actions **agreed.**

- 1472.1 The Clerk presented a copy of the Accounting Statement for 2014/15 together with the Annual Governance Statement for approval. It showed a closing balance of £10,469 with a total asset value of £9,160 the report was **accepted** and the Chairman signed the Accounting Statement.
