- 1210 To sign the register and receive apologies
- 1210.1 Community Councillors present Chairman M. Williams, D. Briggs, A. Edwards, L. Gardiner, A. Jones, G. Lewis, H. Speck and W. Williams.
- 1210.2 Apologies were received from K. Masson, H. Rowlands and J. Watkins.
- 1211 To receive a report from the Police
- 1211.1 Jeff Dugmore gave his apologies for not attending.
- 1212 To receive a report from County Borough Councillor Leon Gardiner.
- 1212.1 Leon said that signage on the Abernant Road junction with the A4048 was to be improved. Hollybush was to be supplied with mains gas the funding was from the E.U. with the assistant of Gwyn Price A.M.

A question was raised about the fact that the Borough Council had removed the bulk collection charge on items such as fridges and three piece suites but was charging for the collection of carpets from houses. The Clerk agreed to contact Tony White from Public Services to clarify the policy.
