Minutes of Argoed Community Council meeting held on 18th January 2016 at Argoed Village Hall.

- 1532 To sign the register and receive apologies
- 1532.1 Community Councillors present: Chairman Walter Williams, L. Gardiner, K. Masson, G. Lewis, J. Watkins and M. Williams
- 1532.2 Apologies were received from Councillors A. Jones and H. Rowlands
- 1533 To receive a representative from the Police
- 1533.1 No police representative was present.
- 1534 To receive a report from Cllr Leon Gardiner.
- 1534.1 Cllr Gardiner gave a brief report on his activities for the previous few months as Mayor of Caerphilly County Borough Council. He was pleased to report that his Charity appeal was in excess of £10,000. The Borough Council had not set the Council Tax for 2016/17. He spoke of the problems experienced by the tenants living in Penylan Road. More houses are to be done on the opposite side of the road.
 - He finished by expressing his concerns about the Local Government reorganisation proposals.
- 1535 The minutes of the previous meetings held on 21 December 2015 and 11th January 2016 were agreed.
- 1536 Matters arising:-
- 1536.1 Minute 1516.1 resignation of Cllr David Briggs. It was agreed that Cllr Mike Williams would become the Vice Chairman until the AGM in May.
- 1536.2 Minute 1514.3 the chevrons were still missing from the south side of the double bend on the road to Manmoel
- 1536.3 Minute 1524.1 loose paving sab at junction of Penylan Road and A4048. Cllr Gardiner agreed to take this up with the Borough Council.
- 1536.4 Minute 1529 it was reported that there were no Christmas tree lights in Manmoel. The Clerk agreed to raise this with the contractor.

- 1537.9 Notice Boards Cllr John Watkins agreed to speak to James Bower about local suppliers for notice boards. It was agreed that the Clerk should place a notice of the Community Council's website on each of the existing notice boards.

- 1538.1 The financial position of the Community Council as at 18th January 2016, showing a total balance of £14,956.63 was **accepted.**
