1759 To sign the register and receive apologies

1760.1 In his absence, PCSO Jeff Dugmore submitted a written report. PCSO Dugmore had submitted ASBO referrals during the last month. The "Your Voice" surveys had been finalised and the main issue raised was youths congregating at the rear of the Markham Institute.
