- 1329.1 Jeff Dugmore reported that the off-road bikers and 4x4's had gone quiet at present. Parking outside Markham Primary School was still causing a problem. He had spoken to several drivers who have been inconsiderately parked in the bus stop. Children are causing problems in Monmouth Walk and Mountain View.
