Minutes of Argoed Community Council meeting held on 19<sup>th</sup> June 2017 at Argoed Village Hall.

- 1707 To sign the register and receive apologies
- 1707.1 Community Councillors present: Chairman M. Williams, S. Blakeman, A.
- Davies, D. King, G. Lewis, H. Rowlands, J. Watkins and W. Williams
- 1707.2 Apologies were received from A. Jones and K. Mills
- 1708 To receive a report from the Police

1708.1 There was no Police representative present at the meeting

- 1709 To receive a report from County Councillor Walter Williams
- 1709.1 Cllr Williams said that he had spoken to Inspector Jim Neeson at the residents' meeting. The former Inspector Jason White had reported that Gwent was to have an extra 120 officers.
- 1709.2 There was a new doctor in the Markham Surgery and the new chemist still hadn't acquired a shop in Markham.
- 1709.3 Cllr Williams said that he was originally holding monthly Council surgeries but no members of the public had attended. He was thinking that door to door may be more effective.
- 1709.4 The yellow lines outside Markham Primary School have been done.
- 1709.5 Caerphilly County Borough Council is to take over responsibility for parking offences using the Community Support Officers.
- 1709.6 The speed activated signs are to be repaired.
- 1709.7 The Hollybush play area is to be inspected by Caerphilly County Borough Council officers.
- 1709.8 The paved area in Mountain View needs to be weeded.
- 1709.9 Cllr Mike Williams reported that the vandals who had damaged the play equipment in the Markham Miners' Institute had been caught and were made to repair the damaged equipment.
