- 1280 To sign the register and receive apologies
- 1280.1 Community Councillors present: Chairman M. Williams, G. Bineham, A. Jones, G. Lewis, K. Masson, H. Rowlands, and W. Williams.
- 1280.2 Apologies were received from D. Briggs A. Edwards, L. Gardiner, A. Craddock and J. Watkins
- 1281 To receive a report from the Police
- 1281.1 Jeff Dugmore had given his apologies.
- 1282 To receive a report from County Borough Councillor Leon Gardiner.
- 1282.1 Leon had given his apologies for not being at the meeting.
- 1283 The minutes of the previous meetings held on 16th December 2013 and 6th January 2014 were agreed.
- 1284 Matters arising:-
- 1284.1 Minute 1264.2 a Councillor outlined the appeal process that was being followed to oppose the planning approval for the Wind Turbine. He said that ultimately, they would go to the ombudsman.
- 1284.2 Minute 1270.1 it was reported that there had been problems with off-road bikers for the last four Sundays. A Councillor had phoned 101 to report the off-road bikers but the call system had failed.
