1817 To sign the register and receive apologies

1817.1 Community Councillors present:- Chairman Mike Williams, A. Davies, G. Lewis, J. Watkins and W. Williams.

1817.2 Apologies were received from H. Rowlands

1817.3 The Council received a letter of resignation from Cllr A. Jones. It was agreed to write to Ms Jones thanking her for her years of service to the people of Markham.

1817.4 The Council agreed to co-opt Mr Colin Padfield for the vacant seat on Argoed and Ms Mary Parks for the vacant seat in Markham.
