Minutes of Argoed Community Council meeting held on 21st November 2016 at Hollybush Community Centre.

- 1630 To sign the register and receive apologies
- 1630.1 Community Councillors present: Chairman M. Williams, A. Jones, H. Rowlands, G. Lewis, John Watkins and W. Williams
- 1630.2 Apologies were received from S. Blakeman and L. Gardiner
- 1630.3 The Chairman welcomed Mr David King to the meeting. Mr King had applied to be a co-opted member of the Community Council. The Council agreed to Mr King's co-option and he signed the Declaration of Acceptance of Office.
- 1630.4 Keith Masson's resignation from the Council was regretfully accepted. He had explained that he had to resign due to pressure of work.
- 1631 To receive a representative from the Police: PCSO Jeff Dugmore had given his apologies for not attending the meeting. The Chairman commented on the parking problems on Penylan Road and also expressed concern about the speed of vehicles on the road. It was agreed that the Clerk write to Caerphilly County Borough Council requesting that a speed monitoring exercise be carried out.
- 1632 To receive a report from Cllr Leon Gardiner. Councillor Gardiner had previously apologised for not being able to attend the meeting.
- 1633 The minutes of the previous meeting held on 17th October 2016 were agreed.
- 1634 Matters arising: -
- 1634.1 Minute 1623.2 Cllr Walter Williams reported on a meeting held with Rhiannon Passmore. He read out a letter received from the Aneurin Bevan Health Board re-affirming its decision to approve a new pharmacy in Markham. The Doctor has appealed against the decision.
- 1634.2 Minute 1624.4 The Chairman confirmed that letters had been sent to residents of Penylan Road regarding the illegal dumping of rubbish.
- 1635 The schedule of correspondence provided by the Clerk was received and the required actions **agreed**.

Item 1635.5 – Markham Colliery Site – it was noted that the Lottery Fund grant application had been unsuccessful. It was hoped that the Borough Council officers could address the issues raised in the letter and put forward a revised application.

Item 1635.6 – 5 man cleansing team – Cllr Walter Williams reported that the junction of A4048 with Markham Road needed clearing. He agreed to provide the Clerk with photographs which could then be forwarded to the Borough Council.
