Minutes of Argoed Community Council meeting held on 15th March 2021 using MS Teams

- 2109 To sign the register and receive apologies
- 2109.1 Community Councillors present: Vice Chairman Mike Williams, A. Bould, G. Lewis, M. Parkes, J. Watkins and Walter Williams
- 2109.2 Apologies were received from M. Barton, A. Davies, D. Moore, J. Moore and J. Mullen.
- 2110 To receive a report from County Councillor Walter Williams
- 2110.1 Cllr. Williams reported that the Borough Council Budget had approved the implementation of the living wage in relation to employees on the appropriate hourly rate.
- 2110.2 The Local Development Plan had been considered by the Borough Council.
- 2110.3 The WHQS programme was nearing completion.
- 2110.4 Improvements to Cwmcarn Forest Drive and various other projects had been discussed.
- 2110.5 Councillor John Watkins asked about a green energy scheme at the former Markham Colliery Site. Councillor Williams confirmed that it was still included in the Heads of the Valleys Master Plan.
